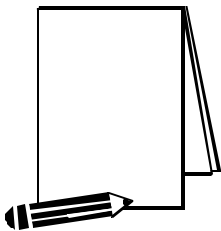

THE SAMPLE

The sample of pHluorus is provided to enable you to prove for your self that indeed the claims of exceeding the daily **ADA** guideline of a .70 Coefficient of friction is possible.

ALL YOU ADD IS WATER

TILE; for unglazed, one part pHluorus to four parts water, example is commercial kitchen quarry tile. For glazed tile, one part pHluorus to eight parts water, example is decorative tile.

TUBS; for all tub applications except fiberglass, a dilution of one part pHluorus to one part water is recommended.

CEMENT; for greasy garage or auto service areas use full strength. For sidewalk areas including steps, one part water to two parts water.

AFTER FIRST TREATMENT

The initial treatment you have applied must be protected with the *pHluorus cleaner*. Simply follow the dilution ratios indicated on the container. **TUB CLEAN** is a ready mix and should not be diluted. Cleaning with pHluorus will block micro-organisms growth and provide a glove like veneer of fluoride. **Caution;** *if you return to your old cleaner the biological/physical safety treatment will be significantly reversed and will void all legally protective affidavits/warranties.*

APPLICATION

To apply pHluorus on-going please read the label attached to the container. **SAMPLE DIRECTIONS;** add water as described in the panel to the left and pour directly on the floor/tub you have selected. Brush briskly with a small hand brush and rinse with plenty of water. Dry with clean towel and allow to air dry. **TEST FOR SLIP-RESISTANCE** by applying water back on treated and untreated surfaces. Use bare hand for bare foot scenario. Follow safety cautions on sample bottle. **Before** 30 day invoice due,
